

PRIVACY STATEMENT

We are committed to protecting your privacy and developing technology that gives you the most powerful and safe online experience. This Statement of Privacy applies to our Practice's website and governs data collection and usage. By using this website, you consent to the data practices described in this statement.

Collection of your Personal Information

This website only collects personally identifiable information that you chose to enter on our contact us page, such as your email address, name and telephone number, which is only used to contact you about the services you are inquiring about. **By providing us with your phone number on our contact us page, you are consenting to receive SMS text related to your inquiry. We will not use your phone number to send any promotional text messages as we are a healthcare office, and this is only used to discuss appointment related messages. However, you can opt-out of texting at anytime by replying UNSUBSCRIBE.**

There is also information about your computer hardware and software that is automatically collected by this website. This information can include: your IP address, browser type, domain names, access times and referring website addresses. This information is used for the operation of the service and to provide general statistics regarding use of this website. This Practice encourages you to review the privacy statements of websites you choose to link to and from the website, so that you can understand how those websites collect, use and share your information. This Practice is not responsible for the privacy statements or other content on any other websites.

Use of your Personal Information

In adherence to the laws of HIPAA we will never sell, rent or lease our customer lists to any individual or any third parties. We also do not disclose sensitive personal health information unless we have expressed written consent in the form of a Release of Information (ROI), in which you, as the patient, indicate who you want to receive information from or want us to send information to another organization. Examples of this can be sending your records at your request to a collaborating provider or to transfer your care at your request. However, this can be revoked by you at any time by written request to our office. Patients of our practice, can discuss this with our office at any time.

The Practice will only disclose your personal information, without notice, only if required to do so by state or federal law. Examples of this would be if there is a medical emergency which requires us to call for medical services such as fire, EMS or police or to report any suspected or confirmed abuse of a child, disabled adult or the elderly. Our full policy is part of your consent packet which will be provided to every patient starting care. Patients can review and discuss with our office and/or their provider at any time.
